**STORAGE**

Tape should be stored in its original packaging in a cool, dry area (not more than 21°C (70°F) and 50% relative humidity) away from direct sunlight and should be used within 12 months of date of shipment.

**RECOMMENDATIONS FOR USE**

Surfaces to which tape is applied should be: clean, dry and free of grease, oil, detergents and other contaminants.

Porous surfaces (walls, plasters, etc.) should be stable (cleaned of old coatings) and primed before application.

The use of Dolphin Glass Tape involves placing the tape on a freshly applied layer of gypsum filler, pressing it to the substrate, removing the excess filler with a putty knife, and then applying another layer of gypsum filler and finishing the surface in accordance with the filler manufacturer's guidelines.
